Assam Congress decides to break ties with AIUFD, BPF

THE OPPOSITION 'GRAND Alliance' in Assam is set to collapse with the state Congress on Monday announcing that it has decided to break ties with Badruddin Ajmal-led AIUFD and the Bodoland Peoples Front (BPF).

A core committee meeting, chaired by state Congress president Bhupen Bora, observed that the AIUFD's "behaviour and attitude in relation with the BJP has affected the members of the Congress," said party spokesperson Bobbeeta Sharma.
