- 5. Figures of the previous quarter/periods have been re-arranged, wherever necessary.
- 6. Due to outbreak of COVID-19 globally and in India, the government has issued orders of lockdown during the first quarter during the month of April and May. Due to lockdown there was slight impact on the revenue of the company in the first quarter ended 30<sup>th</sup> June 2021.
